2. Health Guarantee & Genetic Screening

We recommend that you bring your new puppy to your family vet within 72 hours if you have any concerns about their health and please contact us with any concerns immediately.

3. Buyer's Representations

Buyer represents to Seller that:

- (a) Buyer will not keep the dog chained, or tethered, or permanently housed in a kennel.
- (b) Buyer will provide the dog with necessary veterinary care, including annual vet visits.
- (c) Buyer will not sell, give, or release the dog to a shelter, pet shop, dog dealer, animal testing facility, research facility, or an agent for any such business or facility. Due to the fact that we are a small family breeder, we are unable to take the return of puppies/dogs but we will do our best to work with you if rehoming is needed. - (d) In the event buyer rehomes/sells the dog to a new owner, we request that the buyer notify us of the move and make efforts to ensure the new owner agrees to comply with the terms of this agreement.
