2. Health Guarantee & Genetic Screening

The seller certifies that, upon receipt, the dog is in good health and has been de-wormed on a regular schedule, immunized, and had a physical exam by our family vet (**Foxcroft Veterinary Services at 1441 Dexter Rd, Dover-Foxcroft, ME 207-564-2144**); the results of which are recorded on the accompanying health record of your dog. Both of the parents have passed genetic screening and are cleared of hereditary breed specific genetic material linked to a particular inherited disease. We recommend that you bring your new puppy to your family vet within 72 hours if you have any concerns about their health and please contact us with any concerns.

3. Buyer's Representations

Buyer represents to Seller that:

- (a) Buyer will not keep the dog chained, or tethered, or permanently housed in a kennel.
- (b) Buyer will provide the dog with nutritious food and necessary veterinary care, including annual vet visits.
- (c) Buyer is not acting as an agent for any other person or business in the purchase of the dog.
- (d) Buyer will not sell, give, or release the dog to a shelter, pet shop, retail store, dog dealer, animal testing facility, research facility, or an agent for any such business or facility. Due to the fact that we are a small family breeder, we are frequently unable to take the return of puppies/dogs but we will do our best to work with you if rehoming is desired and we cannot take possession back. We do have a list of applicants that we can contact if you decide to rehome your puppy/dog and need assistance. Please call Rhonda Januskiewicz at 207-951-1513 if this unfortunate decision occurs.
- (e) In the event buyer rehomes/sells the dog to a new owner, we request that the buyer notify us of the move and make efforts to ensure the new owner agrees to comply with the terms of this agreement.
